6. STATEMENT FROM THE CITY ATTORNEY

There have been no directives issued temporarily halting local government processing of land use and development review applications and/or consideration of policy actions including but not limited to General Plan amendments, Zoning Code amendments and new or amended Specific Plans. Therefore, the City of Indio continues to accept and process applications in accordance with state and local requirements. The City of Indio is following Governor Newsom's Executive Orders N-25-20 and N-29-20 pertaining to the Brown Act. These Executive Orders allow governmental entities to conduct meetings by electronic means and for members of the public to observe the meeting electronically as well provide public comment or public testimony telephonically or otherwise electronically. Accordingly, the City Council and Planning Commission are currently conducting scheduled meetings in a virtual meeting format. The City of Indio has implemented technology solutions that allow members of the public to observe and offer public comment as well as public testimony during public hearings at scheduled Planning Commission meetings. The City is committed to providing public participation opportunities while also complying with requirements for the processing of land use and development review applications and/or consideration of policy actions.

- 9. PUBLIC HEARING:

CONTINUED ITEM:

9.1 The 52 Ranch – Tentative Tract Map No. 37756 (TTM 19-10-478) & Environmental Assessment 19-11-545 (EA 19-11-545): The Applicant, Danika Lee, is proposing a Tentative Tract Map No. 37756 ("TTM 37756") to subdivide approximately 34.84 acres of vacant property into 49 new single family residential lots, common areas, and private streets. The proposed project is located 4,100 feet north of Avenue 38 on the east side of Adams Street (Continued last from Planning Commission Meeting of November 25, 2020). (Rosie Lua, Assistant Planner)

Recommendation: Staff recommends that the Planning Commission continue the project to its regular meeting of February 10, 2021 at the request of the Applicant to allow additional time to review and analyze the project. It is also recommended that the Planning Commission open the public hearing and ask for public testimony, but take no action at this time and continue the public hearing to February 10, 2021 at 6:00 p.m.

REGULAR ITEMS:

9.2 Shiraz Rug Tentative Parcel Map No. 37999 (TPM 20-10-406): The Applicant, CCFF Properties, LLC c/o Clifford A. Cole, is proposing Tentative Parcel Map No. 37999 (TPM 20-10-406) to subdivide a single parcel consisting of 2.60 acres into three (3) commercial legal lots for the purpose of sale, lease, or financing within fully development Jefferson Plaza, an existing commercial center. (Rosie Lua, Associate Planner)

Recommendation: Adopt Resolution No. 1972, a resolution of the Planning Commission of the City of Indio, California, recommending to the City Council approval of Tentative Parcel Map No. 37999 (TPM 20-10-406) to subdivide 2.60 acres of a single parcel with a fully improved and operational shopping center into three (3) legal commercial lots for the purpose of sale, lease, or financing within Jefferson Plaza located on the north side of Highway 111 and east of Jefferson Street, subject to the findings and conditions of approval therein, and determining that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15315 (Minor Land Divisions). (Assessor's Parcel Number 600-130-021).

9.3 Indio Medical Office Building – Design Review 20-02-471: The Applicant, Indio MOB – Medical Office Building, is proposing a design review to develop a vacant lot with a two-story medical building totaling 49,990 square feet consisting of 38 offices, 55 exam rooms, and 19 procedure rooms with 230 parking spaces and for the review of the project's architecture, site plan, parking, circulation, and landscaping on a 3.90-acre parcel at the northwest corner of Cheyenne Road and Buffalo Trail. (Nikki Gomez, Assistant Planner)

Recommendation: Adopt Resolution No. 1945, a resolution of the Planning Commission of the City of Indio, California conditionally approving Design Review 20-02-471 to consider the architecture, site plan, circulation, parking, and landscaping of a two-story medical office totaling 49,990 square feet within a 3.90 acre-lot, subject to the findings and conditions of approval therein and determining that the project is exempt from the California Environmental Quality Act CEQA Guidelines Section 15332 (Class 32 - Infill Development).

9.4 Sunburst RV Storage – Design Review 20-01-480 and Tentative Parcel Map No. 38014 (TPM 20-11-407): The Applicant, Columbia Ventures, LLC c/o Guy Evans, is proposing to develop a vacant lot for an RV storage facility consisting of two one-story buildings totaling 30,240 square feet buildings with 18 commercial RV units and for the review of the projects architecture, site plan, parking, circulation, and landscaping on a 1.72-acre lot within the Manufacturing (M) Zoning District. The Applicant is also proposing Tentative Parcel Map No. 38014 (TPM 20-11-407) for commercial condominium purposes for the proposed 18 commercial RV units. (Nikki Gomez, Assistant Planner)

Recommendations:

- 1. Adopt Resolution No. 1976, a resolution of the Planning Commission of the City of Indio, California, conditionally approving Design Review 20-10-480 for the architecture, site plan, parking, circulation, and landscaping for Sunburst RV Storage project with a total of 30,240 square feet building storage facility divided into 18 commercial RV storage units, subject to the findings and conditions of approval therein and determining that the project is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Section 15332 (Class 32 - Infill Development).
- 2. Adopt Resolution No. 1977, a resolution of the Planning Commission of the City of Indio, California, approving Tentative Parcel Map No. 38014 (TPM 20-11-407) to allow a subdivision of a 30,240 square feet RV storage building facility on 1.72 acres located on northeast corner of Sunburst Street and Oleander Avenue, subject to the findings and conditions of approval therein and determining that the project is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Section 15332 (Class 32 - Infill Development).
