

Generally, the City's rules of decorum prohibit comments or actions, which willfully disrupt the meeting. All remarks and questions shall be addressed to the Commission as a whole and not to any particular member. No individual Commissioner or member of the City staff shall be questioned without first obtaining permission from the Presiding Officer. The Commission asks that all persons - including commissioners, staff and the public - act and speak respectfully.
