8. PUBLIC HEARING ITEMS:

Continued Items:

- 8.1 Church at the Red Door Environmental Assessment 20-05-548, Specific Plan 20-05-40, Tentative Parcel Map 20-03-403, Conditional Use Permit 20-10-1064 & Design Review 20-05-474 (Continued from February 10, 2021 and April 14, 2021): The Applicant, Reverend Randy Lintecum, has filed an application with the City to develop a worship center that accommodates a combination of indoor and outdoor uses on an approximately 13.07-acre site to be located at the southeast corner of Jefferson Street and Avenue 49 (APNs: 602-060-001 and 602-060-002). The General Plan and Zoning designations for the project site are Connected Neighborhood (CN) and Country Estates Indio Ranchos 1 (CEIR1), respectively. The Proposed Project will be built out in four phases:
 - Phase 1: The initial phase will consist of one building measuring approximately 20,440 SF supplemented by parking stalls. The building will be utilized as a Sanctuary with a maximum capacity of approximately 584 seats. The building will be constructed on the northwest corner of the site. Entry access is located on Jefferson Street and Avenue 49. Trees with large shade canopies will be planted every four (4) parking stalls, to provide adequate shielding from the sun during high temperature months. Outdoor gathering areas will adorn the exterior of the building. A pedestrian bridge will be located over the existing desert arroyo to the east side of the building. A water feature accompanied by another pedestrian bridge will further enhance the surrounding desert landscape. During Phase 1, a total of 236 parking spaces will be constructed on site.
 - Phase 2: The second phase of the project will consist of a building measuring approximately 6,266 SF. The building will be utilized as a Next Gen/Children's Building and contain breakout areas as well as storage. This is a building for Children's Ministry and Activities and will not be Day School or elementary school. A shared open space and elongated roof will connect the building to the Sanctuary constructed in Phase 1.

- Phase 3: The third phase will consist of a third building to be constructed (administration/next-gen youth) measuring approximately 6,266 SF. A shared open space will create an architectural separation between the buildings. The building will be utilized to further extend the Youth Program and administrative uses.
- Phase 4: The fourth phase will consist of the construction of a building measuring approximately 8,264 SF. This building will be utilized as a multipurpose room and will not be used as overflow worship for the Sanctuary. The building would a large divisible meeting room, a storage room, kitchen, restrooms, and a mechanical room. The expansion of the Sanctuary will also occur during this phase, adding an additional 381 seats for a total of 965 seats. Per the parking requirements, the 236 parking stalls constructed in Phase 1 are sufficient for the Phase 4 Sanctuary expansion. The Church reserves the option to add 123 parking spaces constructed on the southern portion of the site. If implemented, the total parking would grow to 359 parking stalls. (Leila Namvar, Senior Planner)

Resolution No. 1979, a resolution of the Planning Commission of the City of Indio, California, recommending the City Council adopt the Church at the Red Door Specific Plan (CRD-SP) 20-05-40 to establish zoning regulations, development regulations, and design standards for the 13.07-acre vacant property ("Project Site") to located at the southwest corner of Jefferson Street and Avenue 49 (APNs: 602-060-001 and 602-060-002); and,
- 3. Resolution No. 1980, a resolution of the Planning Commission of the City of Indio, California, recommending the City Council approve Tentative Parcel Map No. 37837 (TPM 20-03-403) to subdivide the 13.07-acre Project Site into two (2) parcels to accommodate development of a worship center to be located at located at the southwest corner of Jefferson Street and Avenue 49 (APNs: 602-060-001 and 602-060-002); and,
- 4. Continuation of the following resolutions to a date after the Specific Plan is approved:

- a. Resolution No. 1981, a resolution of the Planning Commission of the City of Indio, approving Conditional Use Permit 20-10-1064 to allow a place of worship (Church at the Red Door) on a 13.07-acre Project Site to be located at located at the southwest corner of Jefferson Street and Avenue 49 (APNs: 602-060-001 and 602-060-002); and,
- b. Resolution No. 1982, a resolution of the Planning Commission of the City of Indio, approving Design Review 20-05-474 for site design, circulations, landscape, and architecture on a 13.07-acre Project Site to be located at located at the southwest corner of Jefferson Street and Avenue 49 (APNs: 602-060-001 and 602-060-002).

Please note that under state law a recommendation for approval on the General Plan amendment and Specific Plan adoption would need to be made by the affirmative vote of not less than a majority of the total membership of the Commission. [Gov. Code Sections 65354; 65453(a).]

8.2 40th Avenue Properties – Tentative Parcel Map No. 37826 (TPM 20-11-409) (Continued from April 14, 2021): The Applicant, Bryan Jensen, is proposing to subdivide a 4.89-acre parcel into four (4) parcels and a remainder lot. The subject property is generally located west of Jefferson St. and south of Avenue 40. (APN: 607-240-015). (Gustavo Gomez, Assistant Planner)

Recommendation: Adopt Resolution No. 1986, a resolution of the Planning Commission of the City of Indio, California, recommending that the City Council approve Tentative Parcel Map No. 37826 (TPM 20-11-409) to subdivide an existing parcel of land into four (4) parcels and a remainder lot subject to the findings and conditions of approval therein and determine that the project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) 15315 (Minor Land Divisions).
