 - 7.1 <u>Recommendation of Public Art and Cultural Affairs Strategic Plan and 2021</u> <u>Work Plan to the City Council:</u> The Public Art Commission, after a long period of strategic planning has produced the Draft Public Arts and Cultural Affairs Strategic Plan as well as the 2021 Work Plan that is derivative of the tenets of the strategic plan. It includes both the completed plans and methodologic description from which the plan emerged.
