6. STATEMENT FROM THE CITY ATTORNEY

There have been no directives issued temporarily halting local government processing of land use and development review applications and/or consideration of policy actions including but not limited to General Plan amendments, Zoning Code amendments and new or amended Specific Plans. Therefore, the City of Indio continues to accept and process applications in accordance with state and local requirements.

The City of Indio is following Governor Newsom's Executive Orders N-25-20 and N-29-20 pertaining to the Brown Act. These Executive Orders allow governmental entities to conduct meetings by electronic means and for members of the public to observe the meeting electronically as well provide public comment or public testimony telephonically or otherwise electronically. Accordingly, the City Council and Planning Commission are currently conducting scheduled meetings in a virtual meeting format. The City of Indio has implemented technology solutions that allow members of the public to observe and offer public comment as well as public testimony during public hearings at scheduled Planning Commission meetings. The City is committed to providing public participation opportunities while also complying with requirements for the processing of land use and development review applications and/or consideration of policy actions.

9. PUBLIC HEARING ITEMS:

9.1 The 52 Ranch – Tentative Tract Map 19-10-478 and Environmental Assessment 19-11-545: A request by The 52 Ranch, LLC, the Applicant, to approve Tentative Tract Map No. 37756 (TTM 19-10-478) to subdivide 34.84 acres of vacant land into 49 single family residential lots, common areas, and streets for a private gated community. (*Rosie Lua, Associate Planner*) **Recommendation:** Staff is requesting the item be continued to the Planning Commission's regular meeting of November 25, 2020 at the request of the Applicant to allow additional time execute agreements between the Applicant and Sun City Palm Desert community. It is also recommended that the Planning Commission open the public hearing and ask for public testimony, but take no action at this time and continue the public hearing to November 25, 2020 at 6:00 p.m.

9.2 <u>Lupian's Commercial Building – Design Review 20-01-469</u>: A request by Abel Lupian, the Applicant, to approve Design Review 20-01-469 to consider the architecture, site plan, circulation, parking, and landscape for a 5,000 square feet multi-tenant industrial/commercial building within a 0.46 acre lot located at the southwest corner of Avenue 45 and Commerce Street. (APN: 611-393-003). (Nikki Gomez, Assistant Planner)

Recommendation: Adopt Resolution No. 1971, a resolution of the Planning Commission of the City of Indio, California conditionally approving Design Review 20-01-469 to consider the architecture, site plan, circulation, parking and landscape for a 5,000 square feet multi-tenant industrial/commercial building within a 0.46 acre lot, subject to the findings and conditions of approval therein and determining that the project is exempt from the California Environmental Quality Act CEQA Guidelines Section 15332 (Class 32 – Infill Development).

9.3 Chandi Plaza – Tentative Parcel Map 20-09-405: A request by Black Gold Engineering, Inc., the Applicant, to approve Tentative Map No. 37974 (TPM 20-09-405) to subdivide an existing parcel (3.01 acres) of land into three (3) legal lots for commercial uses for development of the Chandi Plaza. (Gustavo Gomez, Assistant Planner)

Recommendation: Adopt Resolution 1970, a resolution of the Planning Commission of the City of Indio, California, recommending that the City Council approve Tentative Parcel Map 20-09-405 (TPM 37979) to subdivide an existing parcel of land into three legal lots for commercial uses subject to the findings and conditions of approval therein, and determining that the project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) section 15332 (In-Fill Development Projects).

9.4 <u>Monte Vina – Conditional Use Permit 20-08-1061 and Design Review 20-08-476</u>: A request by D.R. Horton Los Angeles Holding Company and WSI Mojave Investments, LLC, the Applicants, to approve the site plan, architecture, and landscaping plans proposed for 300 single family residential lots and common areas within the Monte Vina community. (*Rosie Lua, Associate Planner*)

Recommendation:

- 1. Adopt Resolution No. 1958, a resolution of the Planning Commission of the City of Indio, California, conditionally approving Conditional Use Permit (CUP) 20-08-1061 to allow construction of two story homes within the Monte Vina community, subject to the findings and conditions of approval therein; and,
- 2. Adopt Resolution No. 1959, a resolution of the Planning Commission of the City of Indio, California conditionally approving Design Review 20-08-476 to consider the site plan, architecture and landscape plans allowing the construction of 300 single family residential lots, common areas and private streets within the Monte Vina community of recorded Tract Map No. 31562 located on the south side of Avenue 44 between Golf Center Parkway and Dillion Road, subject to the findings and conditions of approval therein and determining that the project does not require additional environmental review per California Environmental Quality Act (CEQA).
